

MIDS 2026-2027 Tuition Fee Information

To participate in the 2026-2027 MIDS LL.M. program, tuition fees are set at CHF 28'000.00.

In order to secure your place in the program, you must submit a CHF 700.00 non-refundable deposit. This deposit is paid with the understanding that it will be considered as an advanced payment towards the tuition fees. If, for any reason, you decide to withdraw for the 2026-2027 academic year, the deposit will not be refunded. The payment of the deposit must be made by **Friday, 13 March 2026**.

You may place a deposit before receiving the scholarship decision to reserve your spot, but this is optional and will not affect your scholarship application. Please note that the deposit is non-refundable, even if you withdraw after not receiving a scholarship. If awarded a MIDS-managed scholarship, you will receive a revised Admission and Scholarship Offer Acceptance form.

The tuition fees are payable according to the following schedule:

- CHF 700.00 (seven hundred Swiss Francs) by Friday, 13 March 2026.
- CHF 3'300.00 (three thousand three hundred Swiss Francs) by Friday, 15 May 2026.
- CHF 12'000.00 (twelve thousand Swiss Francs) by Wednesday, 15 July 2026.
- CHF 12'000.00 (twelve thousand Swiss Francs) by Thursday, 1 October 2026.

All payments must be made net of bank charges and exchange fees.

Please note that you may have the option to extend your student status at the MIDS for an additional year after the initial academic program (until Sept. 2028) in order to complete an internship within the scope of your curriculum. At this time, we kindly ask you to note that any extension of your student status requires an administrative fee of CHF 500.00. More information regarding internship options will be provided to enrolled students at a later date.
